Dear Sirs

We are happy to confirm that since March 2003 we have been installing the water -and chemicalfree urinals from URIMAT. At this time 30 pcs URIMAT are in operation.

Since the URIMAT System is installed problems like nasty smell, blockage of pipes and flooded urinals, as well as formation of urine stone have been resolved completely. This brought us to the decision to install more URIMAT Systems in the extension of the Terminals at the Airport. As a consequence for all the new built buildings there will always be URIMAT installed. Thanks to URIMAT the maintenance costs could be reduced. The work of maintenance could be limited to a regular inspection of the systems and the replacement of the siphons.
